Grading has begun at the intersection of Highway 321 and Highway 321A in preparation for the construction of a Sheetz and Starbucks. According to the Sheetz website, the convenience store offers "award-winning Made-To-Order® Foods, Espresso Bar with Made-To-Order® Specialty Coffeez®, quality gasoline at low prices, and the lowest priced cigarettes/tobacco allowed by law." The business promises to be open "24/7/365." They don't even close for Christmas. Starbucks is well known for its "fresh roasted" coffee, but it also provides a variety of food and beverages.

### NEWS FROM GRANITE FALLS Don't Fall for Phony Phone Calls

The Town of Granite Falls sent out a warning on June 30th reminding residents not to fall for a scam where callers threaten to cut off electricity and other utilities unless immediate payment is made by credit/debit card over the phone. First, the Town of Granite Falls does not accept this information over the phone, and, second, the town does not normally disconnect utilities on holidays and over the weekends. While the town provides critical services (fire, police, electricity, and water) 24/7, regular business hours are Monday through Friday from 8 a. m. - 5 p.m. The phone number for the town office is 828-396-3131. Employees are on site during regular business hours, and someone monitors calls 24/7 for utility outages and repair needs.

The police department has someone available to answer phone calls made to 828-396-3358 Monday through Friday from 8 a.m. - 5 p.m., but callers should dial 828-758-2324 at other times for non-emergency needs. **Dial 9-1-1 for police, fire, and medical emergencies.** 



### ANNUAL REPORTS Electric Department

Rick Sisk, Electric Services Director. gave the 2022 annual report for his department on February 6, 2023. As of January 2023, the Town provided electricity to 2,635 customers (residential -2,186, commercial - 405, industrial -6, and municipal -38). During 2022, the town installed

38 new residential services, 2 new commercial services, and 14 temporary services. In addition, workers completed 14 service changes, upgraded 14 underground and overhead services, installed 4 new LED security lights, upgraded 76 existing security/street lights to LED, and performed 1,833 various work orders for connections, disconnections, electric service, voltage quality studies, bad electric connections, streetlight repairs, etc. Also in 2022, the department answered 1,081 calls from the 811 line that encourages people digging holes to "Know what's below. Call before you dig."

To maintain reliable service, the Electric Department has taken preventive measures to prevent interruptions and power outages. The tree trimming programs keeps trees and/or limbs from falling on powerlines, and animal guards keep squirrels out of electrical equipment. The also started replacing all steel construction with polymer or composite because these materials don't conduct electricity. In 2022, workers upgraded 16 poles.

Records for last year show there were 20 outages - 6 were caused by squirrels, 6 by equipment failures, 4 by trees, 1 by old equipment, 1 by a bird, 1 by a vehicle accident, and 1 by lightning.

The Town of Granite Electric Department also upgraded infrastructure during the past year. Workers installed a backup generator at the town office, upgraded an underground primary at 18 and 20 Berkley Avenue, upgraded an underground primary at Southeastern BioMedical Associates, replaced 14 "danger poles," added new underground primary for Duke Street Cottages, and continued upgrading street/security lights from HID to LED.

### Fire Department

Fire Chief Brian Bennett also presented his annual report for 2022 on February 6, 2023. The department is manned by twelve (12) paid employees and six (6) volunteers. Last year, they limited property losses (\$230,800) to .03 average of eight 1,025 calls, spen

(\$230,800) to .03% of the total value (\$588,513,418). An average of eight (8) firefighters per call responded to 1,025 calls, spending a total of 691 hours on calls. The average response time was 3 minutes and 7 seconds. Of the total calls, 782 were inside the city limits with 243 outside. The calls were comprised up medical (46%), false alarms (13%), vehicle accidents (13%), fire (9%), and miscellaneous (19%).

Firefighters completed 2,660 hours of training. Drone pilots trained for 79 hours and had 14 hours of flight time. One firefighter earned his Emergency Medical Technician certification, and one completed state certification to be a firefighter. For the six consecutive year, the department received the Gold Safety Award from the North Carolina Department of Labor.

The Granite Falls Fire Department also assists the community in other ways. During 2022, the department obtained a \$5,000 grant from the League of Municipalities so the Police Department could buy parking lot bollards. During Fire Prevention Week, firefighters taught 101 children at Granite Falls Elementary School about fire safety. Safe Kids World Wide has designated the Granite Falls Fire Department as a permanent car seat checking station.

# Dateline: Granite Falls, N. C. 1981 - 1991

From Etched in Granite, The History of Granite Falls, North Carolina by Maxine McCall

- In 1981, Chief of Police Ralph "Rusty" Barlow retired after 27 years of service.
- In June 1982, Catawba Valley Cable TV began offering its services to residents in Granite Falls and Rhodhiss. Prime Cable purchased the system in 1987 and eventually sold out to Charter Communications, the current owner, which goes by the trade name Spectrum.
- In 1985, the fire department received more good news from the Insurance Services Office (ISO) with a Class 5 rating.
- In October 1985, the town council approved the purchase of a 1986 White-Grumman pumper-tanker with the hauling capacity of 1,000 gallons of water and a pumping capacity of 1250 GPM. This vehicle replaced the 1953 Ford American-LaFrance 500 GPM pumper.
- In 1986, the fire department began training members to be First Responders and Emergency Medical Technicians, so the fire department could respond to medical emergencies.
- In 1987, the Olympic Torch passed through Granite Falls enroute to a special event in Raleigh.
- On September 22,1989, Hurricane Hugo hit Granite Falls with sustained winds of 85 mph, knocking out 30% of the electrical system. Town crews with mutual aid from other ElectriCities members restored power to all residents within 4 days. Large numbers of people in Caldwell County went without power for up two weeks. Disaster relief from the Federal Emergency Management Agency (FEMA) provided \$500,000 to clean up and rebuild the electrical system.

One of the hardest hit areas was Crestview Street. Shown in the photo is the home of Mayor A. W. "Bert" Huffman. The photo is a still image from a video made after the storm passed.

Remnants of the First Self-Serve Gas Pumps in Granite Falls

#### Down Memory Lane with Linda Richards Crowder

Earlier this year, I learned that PNC Bank in Granite Falls had replaced tellers with ATMs in February. This makes me wonder - is this the future for banking? We will have to wait and see if more banks follow PNC's lead.

Alas, ATMs may well be the future. Years ago, we adjusted to self-service gasoline pumps, giving up full service stations where attendants cleaned windshields, checked tire pressure, and inflated tires in addition to pumping our gas. This brings me to the photo at the top of this column. These are the remnants of what I believe to be the first self-serve gas pumps in Granite Falls. In the bushes in the background, you can see the remains of a dilapidated kiosk from the same time period. These remnants of a bygone era are located next to Perry's Corner, which currently houses City Grind and Al's Diner.

I don't know when they were installed or when they were abandoned, but they were there in the early 80s. Jonathan Fox, the grandson of the man who sold the property to the entrepreneur who brought self-serve to Granite Falls, remembers helping his grandfather maintain the pumps along with the vending machines that sold soft drinks and eggs. (Yes, eggs!)

Jonathan's grandfather was Perry Starnes. He was married to my father's sister Hattie. Uncle Perry owned/operated the City Café on South Main Street and had a Nationwide Insurance office in the back. According to a copy of an ad his daughter, Betty, gave me, he sold the café to Mr. and Mrs. Harold Reid

The Granite Falls Historical Association is pleased to announce that two local men - Tommy High and Chris Newsom - have collaborated to produce a spreadsheet containing information about people buried in Pinecrest Cemetery. Tommy based his file on years of research and personal knowledge. Chris based his work on the Find A Grave® website, which he updated after taking photos of tombstones. Chris merged his file with Tommy's, researched discrepancies, and reconciled the differences. While no listing can be 100% accurate due to poor record keeping in the early years and human error over the years, the file will be a valuable resource for persons wishing to locate burial sites or do research. The Association plans to keep the spreadsheet updated as needed and to make them available to the public upon request.

Perry didn't stay away from the food industry long. He decided to build a new restaurant and an insurance office in front of a house he owned at 47 Falls Avenue. Betty told me that Garland Marshall, the building inspector, initially refused to issue a permit, but Perry got up early one morning and started digging the foundation. Mr. Marshall changed his mind and issued a permit on September 8, 1961. The estimated cost was \$12,000.00, and the builder was listed as Ted Seigel. (see photo below)

Perry called his restaurant the Town Drive-In. He specialized in seafood, but he also served sandwiches. Betty remembered being excited because everything was new, unlike the City Café, which used items passed on by previous owners.

After Perry closed the Town Drive-In, he leased the building so others could operate businesses there. If walls could talk, they would reveal a lot of memories. Perry's family continues to own the property, and I am looking forward to seeing what happens next at Perry's Corner.
