HISTORY IN THE MAKING COVID-19

Although COVID-19 cases continued to climb in August, Governor Roy Cooper refrained from reinstating mask mandates. At a news conference on August 18, 2021, he urged individuals to wear masks indoors and to get vaccinated. He noted that some businesses and government entities were requiring vaccinations and masks, and he urged others to do the same.

U. S. Department of Health and Human Services: On August 18th, top COVID advisors expressed concerns about the decline in efficacy of the Pfizer and Moderna vaccines. While they wait for additional studies to be completed, they are preparing to give booster shots in September to the persons who received the vaccine first.

On August 20th, the CDC website recommended that persons with moderate to severe compromised immunity be given a third dose of Pfizer or Moderna.

Town of Granite Falls: On August 20th, the Town of Granite Falls announced on its Parks and Recreation Facebook page that face coverings would be required for everyone, regardless of vaccination status, indoors at all town facilities beginning Monday, August 23rd.

Festival on Main: For the second year in a row, the annual Festival on Main, sponsored by the Granite Falls Merchants' Association, has been cancelled.

Schools: The Caldwell County Board of Education held another meeting on Monday, August 16th to revisit the topic of mask mandates, but decided to leave in place

GRANITE FALLS HISTORICAL ASSOCIATION Update

Members of the Granite Falls Historical Association held a special meeting on Tuesday, August 24th in the museum to hear an update from the Board of Trustees and to plan an Annual Meeting. Members designated a chair in memory of charter member Rader Kiziah who passed away August 22nd. Rader was a graduate of Granite Falls High School and a veteran of both World War II and the Korean War.

the earlier decision to remain optional. After increasing COVID cases affected the schools, the school system announced on Friday, August 27th that wearing masks indoors on school grounds would become mandatory on August 30th for everyone.

Courts: Candice Simmons of the *News-Topic* reported in a front page article on August 18th that Judge Robert C. Ervin, the chief Superior Court Judge for Caldwell County issued an administrative order on Tuesday, August 17th to require masks in court houses. The article also mentioned that a judge had to declare a mistrial earlier this summer because three jurors had tested positive for COVID-19. Another trial had to be delayed after a law enforcement officer became ill with the virus.

Jeanne Whisnant is working on oral histories to be included in *Etched in Granite, Volume II*. She has already interviewed several people. Metaleen Thomas reported that the Pinecrest Mapping Project is still on hold due to COVID. Teachers who had previously expressed an interest in having their students participate cannot make commitments this early in the year. She will monitor and follow up as appropriate.

They are Linda Crowder (president), Dr. Caryl Burns (vice president), Adele Mangan (treasurer), Jeanne Whisnant (secretary), and Gifford Poe (parliamentarian). The floor will be open for additional nominations prior to the formal election to be held during the Annual Meeting on Tuesday, October 26, 2021 in the museum beginning at 6:30 p.m. Perspective members are welcome to join the Association, which is dedicated to preserving the history of Granite Falls, North Carolina.

The museum is located in the historic home of Andrew Baird, an early settler. The building is the second oldest residence in Caldwell County. The Baird House was built around 1795 with additions made over the next hundred years. The house remained a residence until 2001 when the owner sought permission to have it burned down due to the high cost of maintenance. Recognizing the historical significance of the building, the Town of Granite Falls purchased the home with the intentions of turning it into a museum. With the help of a grant from the North Carolina Department of Transportation and hours of hard work by dedicated people, the vision became a reality.
