Ribbon Cutting & Dedication

Caldwell County Schools held a ribbon cutting and dedication ceremony on Thursday, October 4, 2022 at 5:30 p.m. to celebrate the final construction phases at Granite Falls Middle School. Speaking from the new entrance at 4 West Highland Avenue, Dr. Don Phipps, Caldwell County Schools Superintendent, welcomed everyone and introduced the South Caldwell High School NJROTC under the direction of Col. Greg Woodward, Senior Naval Science Instructor, for the posting of colors and the GFMS School Choir under the direction of Stephanie Peek, Chorus Director, for singing the National Anthem. Dr. Phipps then led the crowd in pledging allegiance to the U. S. Flag.

Special speakers for the occasion were Andy Puhl, Assistant Superintendent of Auxiliary Services; Darrell Pennell, Chairman of the Caldwell County Board of Education; Vern L. McKissick III, Owner/Architect/Educational Planner for McKissick Associates; Aaron Beam, Building Division Manager for Hickory Construction Company; Dr. Caryl Burns, Mayor of the Town of Granite Falls; and Randy Church, Chairman of the Caldwell County Board of Commissioners. The Caldwell County Chamber of Commerce assisted with the ribbon cutting. After the ceremony, GFMS students gave tours of the main building and the renovated gymnasium. HISTORY IN THE MAKING

Living with COVID-19

Caldwell County: COVID-19 remained an unwanted house guest in many homes, but the Centers for Disease Control (CDC) showed the county level as low risk from October 6th through October 27th.

Federal News: On Wednesday, October 12th, the CDC authorized the use of the updated COVID vaccine (bivalent) that includes the Omicron BA.4 and BA.5 spike protein components. The new authorization allows children ages 5 through 11 to receive the Pfizer-BioNTech vaccine and children ages 6 through 17 years to receive the Moderna brand.

On Wednesday, October 19th, the CDC announced a decision to allow adults (18 up) the option to receive a Novavax monovalent booster instead of Pfizer-BioNTech or Moderna if they have had the first series, but not the booster or if they can't or won't take a mRNA vaccine.

GRANITE FALLS HISTORICAL ASSOCIATION *Fifth Annual Meeting*

The Granite Falls Historical Association held its Fifth Annual Meeting on Tuesday, October 11, 2022 in the Granite Falls History and Transportation Museum at 7 p.m. President Linda Crowder began the meeting with reports on current projects.

Update to *Etched in Granite*: Linda has completed a chronological history of Granite Falls from January 1999 through September 2022. She plans to start editing and double checking her work in early 2023, and she is seeking volunteers to assist her. Linda suggested changing the name from *Etched in Granite, Volume II* to *Dateline: Granite Falls, North Carolina* to avoid having to deal with copyright issues and to better reflect the newsfeed format she is using.

The Pinecrest Mapping Project: Tommy High reported that he has lost the thumb drive containing the digital version of his cemetery records. A friend has started recreating the file.

Baird Cemetery: Linda reported that a Boy Scout leader is checking on the feasibility of having a candidate for Eagle Scout undertake the project. With cold weather approaching, the cemetery should be okay until spring. Joel Kaufman will continue to monitor the cemetery and let the trustees know if any action needs to be taken in the interim.

Business Session: Members voted to have the trustees audit the treasurer's report. They also elected the following officers to serve for 2022-2023: President Linda Crowder, Vice President Jeanne Whisnant, Secretary Joel Kaufman, Treasurer Adele Mangan, and Parliamentarian Gifford Poe.

Announcements: Linda announced that the next meeting of the Board of Trustees will be held on Tuesday, November 15th following a History Committee Meeting at approximately 2:45 p.m. This will be the organizational meeting for the new fiscal year. First on the agenda, the officers will appoint up to four (4) trustees to assist them during the coming year. Then the Board will audit the financial records, review the status of pending projects, and consider other business as appropriate. All members may attend the meeting, and new members are welcome. If anyone is interested as serving as a trustee, please let Linda know.

Following the business session and a refreshment break, members viewed a PowerPoint® presentation showing photos made by Linda of the new construction, demolition, and renovation at Granite Falls Middle School. The slide show also featured photos of the 1902 wooden structure that housed the first public school in Granite Falls on North Main Street, the 1922 Falls Avenue building, the 1935 high school that was recently renovated, and the 1950 junior high that was torn down.

During the Annual Meeting, the treasurer also accepted dues for the 2022-2023 year, which runs from November 1st to October 31st. Persons who were not able to attend may mail dues to Adele Mangan, 33 Crestview St., Granite Falls, N. C. 28630.

TO THEE, OLD GRANITE HIGH SCHOOL

Thy Praises We'll Ever Sing! We'll Hold Thy Standards Throughout Life and Keep Thy Honor Clean.

The new Granite Falls Middle School cost about \$25 million with the N. C. Education Lottery providing \$15 million. When the project started, the school had approximately 45,000 square feet of space. Roughly half was demolished, including the office space built between the two buildings, the lower building (aka "junior high"), and the old shop. There is now 54,000 square feet of new construction, which features environmentally friendly LED lighting and super insulated concrete forms (R-45). Reusing the 1935 building and the 1948 gymnasium has been deemed more energy efficient than making new brick and mortar. The 1935 building now houses the "technitorium," which consists of the kitchen, shared dining-study area, media lab, guidance offices, and classrooms for Career and Technical Education. Renovations in the gym include an elevator, remodeled locker rooms, and new flooring.





The museum is located in the historic home of Andrew Baird, an early settler. The building is the second oldest residence in Caldwell County. The Baird House was built around 1795 with additions made over the next hundred years. The house remained a residence until 2001 when the owner sought permission to have it burned down due to the high cost of maintenance. Recognizing the historical significance of the building, the Town of Granite Falls purchased the home with the intentions of turning it into a museum. With the help of a grant from the North Carolina Department of Transportation and hours of hard work by dedicated people, the vision became a reality.
