MAKING HISTORY Retirement Reception for Mayor Barry Hayes

The Town of Granite Falls hosted a retirement reception for Mayor Barry Hayes in the Family Life Center at First Baptist Church of Granite Falls on Sunday, March 20, 2022 between 2 and 4 p.m. to celebrate his 42 years of service to the town. In 2021, Hayes chose not to seek re-election after serving as mayor for 24 years. Prior to that, he served on the town council. Dr. Caryl B. Burns, who succeeded him as mayor, and Town Manager Jerry Church presented him with gifts from the town - a gavel, a service plaque, and a framed photo of the falls for which the town is named. Joe Gibbons, Mayor of Lenoir, and Ronnie Setzer, Mayor of Cajah Mountain, also presented him with gifts. Numerous persons, including members of the town board, former town employees, and residents publicly thanked the retired mayor and expressed their appreciation to him.

HISTORY IN THE MAKING COVID-19

When COVID cases started declining in February 2022, the Centers for Disease Control updated its mask guidelines to distinguish between low, medium, and high risk areas. On February 25th, the CDC set up a COVID tracker on its website to show the status of each county in the United States. The agency assessed the risks by considering the number of new cases, new admissions to the hospital, and the availability of hospital beds.

Caldwell County was in the high risk category when the tracker first appeared and was still there on March 3rd even though the Caldwell County website showed only five (5) persons in the hospital with the virus as of March 2nd, the last day of the report period (February 23rd - March 2nd). However, a note on the dashboard explained that the report included cases previously reported to the state, but not to the county. These were found when the county searched state records. After both websites updated their records (Caldwell County on March 9th and the CDC on March 10th), Caldwell County began showing in the low risk category.

On March 17, 2022, Governor Roy Cooper held a press conference to discuss his plans moving forward. He said, "Over the last two years, we've written a history of hardship and resilience, setbacks and successes. But now, we enter the next phase. One of individual responsibility, preparedness and prosperity. The virus will still be with us, but it won't disrupt us."

The news release sent out by the Governor's Office about the press conference included a document detailing his plan. It was called "Moving Forward Together: The Next Phase of North Carolina's COVID-19 Pandemic Response. The plan noted that "North Carolina had the lowest per capita deaths in the southeast and among the lowest in the nation," "Statewide hospital capacity has never exceeded 91%," and "Statewide ICU capacity has never exceeded 89%."

The governor also announced a change in the reporting of statistics. Over the past two years, the North Carolina Department of Health and Human Resources has posted COVID metrics (number of new cases, number of tests administered, and number of persons admitted to the hospital) on its website daily Monday through Friday except on holidays. Beginning on March 23rd, the NCDHHS would update the metrics on Wednesdays to show the level of virus particles found in wastewater, emergency room visits with COVID symptoms, healthcare capacity, hospital admissions, status of vaccinations/boosters, detection of virus variants, and community levels shown by the CDC.

Vaccine: Meanwhile, vaccine manufacturers continued their research. On March 23rd, Moderna announced plans to seek approval for its lower dosage formula for children ages 6 months to 6 years. The company is still waiting on authorization for its vaccine formulated for ages 6 to 11.

On March 29th, the FDA announced emergency authorization for certain persons to receive a second booster shot of the Moderna or the Pfizer-BioNTech COVID vaccine. Either vaccine may be given to those 50 years of age and older. Persons who are 12 and older may receive a second booster of the Pfizer-BioNTech if they are immunocompromised. Persons ages 18 and older may receive a second Moderna booster if they are immunocompromised. Second boosters may be given at least four (4) months after the first booster.

COVID Test Kits: During his State of the Union address on March 1, 2022, President Joe Biden announced that he would authorize the post office to send four (4) additional home test kits per household upon request beginning March 7th. The website is <u>COVIDtests.gov</u>. Persons without internet access may order by phone by calling 1-800-232-0233. There is also a TTY number 1-888-720-7489 for hearing and speech impaired persons. The hours are 8 a.m. until Midnight (EST)), seven (7) days per week. Persons with other disabilities may call 1-888-677-1199 Monday through Friday from 9 a.m. until 8 pm. (EST) or send an email to DIAL@usaginganddisability.org.

Other Free Programs End: On March 16th, Health Resources and Services Administration said it would stop accepting claims from healthcare providers for testing and treatment of uninsured patients under the HRSA COVID-19 Uninsured Program (UIP) after 11:59 p.m. on March 22, 2022. In addition, HRSA would stop accepting claims for reimbursement for vaccine administration after 11:59 p.m. on April 5, 2022.

COMING TO THE MUSEUM Vintage Clothing

Before the museum shut down due to COVID - 19, the History Committee had planned a showing of vintage wedding gowns. Now that life is returning to normal, members have decided to reschedule the exhibit for June 2022 and to include other vintage garments. The committee will also accept photos of wedding gowns since many have been boxed for safekeeping. Items to be displayed may be taken to the museum between 2 and 4 p.m. on May 15th and 22nd. Please be sure the owner's name and contact information is on each piece.

One of the garments to be displayed at the exhibit is the beautiful, handmade suit shown packed in a box on the right. It belonged to Alice Surles Corpening, the wife of Dr. Oscar J. Corpening, who practiced medicine in Granite Falls from 1906 until 1969. They were married on November 15, 1911.
